1. Introduction to the Project

The Administrative Circular includes the most relevant organizational aspects of the APEC Workshop on the Application of Electronic Veterinary and Phytosanitary Certificate to be hosted virtually by Chinese Taipei.

2. Objectives

Sanitary and phytosanitary (SPS) measures aim to prevent transmission of animal or plant pests or diseases through international trade of agricultural products. By conducting SPS measures properly, APEC member economies can prevent animals and plants from exposure to pathogens and pests, ensure and stabilize the agricultural production and quality, and protect the health or life of humans, animals and plants. The veterinary or phytosanitary certificates are important and necessary official documents noting SPS measures for international trade of agricultural and livestock products. In addition, in response to the COVID-19 pandemic, digital technologies have become a global trend for the issuance and inspection of veterinary or phytosanitary certificates.

The project's overall goal is to provide a forum for APEC member economies to share experiences and discuss the challenges in the application of electronic veterinary or phytosanitary certificate (e-certificate) in order to find relevant solutions for trade facilitation on animal and plant products. This workshop will provide capacity building to most APEC member economies through the experiences shared by members on practical application and developing e-certificate system through bilateral or multilateral channels, including systems under international organizations (i.e., IPPC ePhyto). This information will help APEC members analyze and decide on the establishment of their systems. It will also provide APEC member economies with an opportunity to discuss acceptable alternatives to paper/e-certificates including digital technologies like QR Code or an official online database of veterinary or phytosanitary certificates, and safety issues thereof.

In this workshop, we will:

- 1. Introduce the veterinary and phytosanitary e-Certification;
- 2. Discuss the application of e-Certification;
- 3. Share practices on using alternatives such as QR code or an official online database.

Particular emphasis will be placed on recommendations that may inform future policy development. As part of capacity development for sustainable economic growth, this

project will provide a forum for building the capacity of APEC member economies to improve and implement measures that can not only prevent the spread of animal and plant pests and diseases, but also facilitate trade of animal and plant products, and ensure a stable agricultural production, food security and trade environment in the Asia-Pacific region.

A project report will be conducted after the workshop. The project report, which includes a summary of the survey results and a workshop summary, will contribute to the development of policy recommendations by sharing best practices and identifying specific actions that can build the capacity of APEC member economies in this regard.

3. Agenda

The workshop will be conducted in English. Kindly speak more slowly than usual since the audio quality may deteriorate in an online platform. At the conclusion of the final day of the workshop, participants will be asked to complete a simple workshop evaluation form. - use a headset with a built-in microphone to ensure high audio quality;
- mute their microphones, except when they need to speak;
- use the chat function when asking questions; and

The workshop is structured with the intent of maximizing discussion and the exchange of ideas among participants and speakers.

Speakers funded by APEC will assume responsibility for any other expenses incurred during their presentations. They will also make their own arrangements for any other financial matters of a personal nature. APEC highly values collaboration with appropriate external stakeholders. Attendance of nominees for this Workshop who are not government officials (or part of a government delegation), for instance from the private or academic sectors, may be subject to Forum Agricultural Technical Cooperation Working Group (ATCWG) approval as per APEC Guidelines.

<u>On Day One</u>, this virtual workshop will provide a forum for APEC member economies to share successful experiences and benefits from the application of electronic veterinary and phytosanitary certificates (e-certificates) to improve efficiency of cross-border trade operations. Workshop participants will also have opportunities to learn several types of e-certificate systems and how to use "e-Phyto Solution" or innovative technologies to facilitate the exchange of e-certificates through bilateral or multilateral channels.

<u>On Day Two</u>, this workshop will bring together experts from governments, academic communities, and private sectors to present case studies from using innovative platforms (e.g., QR Code), focusing in particular on the challenges and conditions associated with the expanded use of these technologies as possible alternatives and equivalent to traditional paper certificates or e-certificates. The important role of APEC as a regional organization for information sharing and capacity building will also be discussed.

A summary report will be submitted to APEC, and the same will be presented during the first APEC Senior Official Meeting in 2023.



- When listing member economies, the names should be separated by semi-colons (e.g. Australia; Hong Kong, P.R. China; Brunei Darussalam; Canada).
- Please be mindful of using the correct names of APEC economies in your presentations. Refer to the list below for accepted abbreviations for APEC economies.
